

RULES AND REGULATIONS OF ONLINE PURCHASE OF BEAUTY GIFT CARDS

GLOSSARY

Seller – shall mean DR IRENA ERIS Spółka Akcyjna, ul. Armii Krajowej 12, 05-500 Piaseczno, NIP (Tax Identification No.): 1230288525, REGON (Business Statistical No.): 012186410, District Court for the Capital City of Warsaw in Warsaw, 14th Commercial Division of the National Court Register, KRS (National Court Register No.): 0000051003, paid-up share capital of PLN 35,313,800, email address: Instytuty.Biuro@DrIrenaEris.com, issuing a Beauty Gift Card;

Beauty Gift Card – shall mean a bearer gift card with an assigned serial number and a pre-defined value which can be redeemed by the Buyer at one of the Skin Care Institutes;

Buyer – shall mean the person receiving a Beauty Gift Card from the Seller in exchange for payment of a pre-defined amount, considered to be a consumer under the Polish Civil Code and having unlimited capacity to perform acts at law;

The Seller and the Buyer shall be jointly referred to as the Parties.

This document constitutes the rules and regulations of the online store at Instytuty.DrIrenaEris.com.

The store is operated by Dr Irena Eris S.A., ul. Armii Krajowej 12, 05-500 Piaseczno.

These Rules and Regulations lay down the terms of online sale of Beauty Gift Cards and are binding upon the Seller and all Buyers using the online store, who are required to read these Rules and Regulations. The provisions not regulated under these Rules and Regulations shall be governed by the Civil Code.

The Beauty Gift Cards shall be sold online in the form of a distance contract between the Buyer and the Seller.

Purchasing, by electronic means, Beauty Gift Cards which specify the full name of the third party for whom they are purchased, but who is not the Buyer, for the purpose of its further delivery by the Seller in the form of a courier parcel shall not be possible due to the fact that the Seller has failed to obtain the third party's consent to the processing of their personal data. The above results from the changes introduced by the provisions specified in detail in Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), referred to as GDPR.

Dr Irena Eris S.A., referred to herein as the Seller, has the exclusive right to operate the above-referenced store.

The Beauty Gift Cards offered at Instytuty.DrIrenaEris.com are brand new, free from physical and legal defects, and are lawfully marketed in Poland.

I. ACCEPTING ORDERS

- 1. The sale of the Beauty Gift Cards is operated by the online store via the Internet.
- 2. To place an order, the Buyer is advised to use the latest versions of Internet browsers. The browser should have JavaScript and cookies enabled.
- 3. Acceptance of a placed order by the Seller is tantamount to the conclusion of a Contract.
- 4. Each Beauty Gift Card shall be valid for the period specified thereon. The validity period of a Beauty Gift Card shall not be shorter than 4 months from the date of its purchase by the Buyer.
- 5. The processing of orders placed on business days after 5 p.m. and on Saturdays, Sundays and holidays shall begin on the next business day.
- 6. Placement of an order at the online store is tantamount to acceptance of these Rules and Regulations.
- 7. Once the order is placed, the processing will begin. The Buyer may choose to pay via PayU, or by cash or card when collecting the Beauty Gift Card at the Seller's premises.
- 8. Product information provided in the online store at Instytuty.DrIrenaEris.com does not constitute an offer within the meaning of the Civil Code but an invitation to conclude a contract.
- 9. By filling in the order form, the Buyer makes an offer to purchase the selected Beauty Gift Card. The Buyer shall be obliged to provide the following data in the form:
- a) full name,
- b) email address,
- c) correspondence address,
- d) phone number,
- e) corporate customers are also required to provide the company name, address and the NIP number.

- 10. By placing an order, the Buyer agrees to pay the amount specified in the order for the selected Beauty Gift Card.
- 11. Once the payment is made, any changes to the order must be agreed by telephone: 22 541 71 30 or via email at: Instytuty.Biuro@DrIrenaEris.com.
- 12. Communication with the Buyer shall take place from the email address: Instytuty.Biuro@DrIrenaEris.com or telephone number: 22 541 71 30.

II. COMPLAINTS PROCEDURE; REPORTING DEFECTS IN ITEMS SOLD

- 1. Matters relating to non-conformance of the purchased product with the contract are regulated by the Act of 30 May 2014 on Consumer Rights, consolidated text of 28 January 2020 (Journal of Laws of 2020, item 287), and the Civil Code. In the case of any complaints involving Beauty Gift Cards, please contact the Seller via email at: Instytuty.Biuro@DrIrenaEris.com
- 2. To report non-conformance of a Beauty Gift Card with the contract, the Buyer must provide their full name, order number or billing number (Sale Note), describe the cause of non-conformance, and specify the demanded remedy, as stipulated in Article 560 of the Civil Code, i.e. value reduction, withdrawal from the contract, exchange of the item for a defect-free item or removal of the defect. The Seller shall respond to the consumer's demands within 14 days, at the latest. Any non-conformant Beauty Gift Card shall be returned to: Dr Irena Eris S.A. ul. Puławska 107A, PL 02-595 Warszawa.

III. WITHDRAWAL FROM CONTRACT

- 1. As provided for in the Act of 30 May 2014 on Consumer Rights, consolidated text of 28 January 2020 (Journal of Laws of 2020, item 287), any Consumer who has entered into a distance contract may withdraw from the contract within 14 days (from the date of delivery of the item) without giving any reason and without any cost. To withdraw from the contract within the withdrawal period, the consumer must send a written declaration prior to the expiry of the withdrawal period via email to Instytuty.Biuro@DrIrenaEris.com or by post to ul. Puławska 107A 02-595 Warszawa.
- 2. In the event of withdrawal from the contract, the contract shall be considered not concluded and the Buyer shall be released from any obligations arising thereunder. Whatever the Parties have furnished shall be returned unchanged, save where a change was necessary in the ordinary course of business. Mutual considerations by both Parties must be returned promptly but no later than within 14 days. The purchased Beauty Gift Card shall be returned to the following address: ul. Puławska 107A, 02-595 Warszawa. The Seller shall refund the amount paid for the products returned (the total amount paid for the products + the cost of shipping from the Store to the Consumer) within 14 calendar days.
- 3. Pursuant to Article 38 of the Act on Consumer Rights, consolidated text of 28 January 2020 (Journal of Laws of 2020, item 287), the Buyer shall not have the right to withdraw from the contract where the service has been performed with the consumer's express consent and the consumer has been informed beforehand that they shall lose the right of withdrawal once the service has been performed.

IV. VALUE

- 1. All values are expressed in Polish zlotys.
- 2. The value shown for each Beauty Gift Card is binding at the time the order is placed by the Buyer.
- 3. The Seller reserves the right to change the value of the Beauty Gift Cards offered. Value changes shall not apply to Beauty Gift Cards that have been already ordered by the Buyer.

- 4. The Seller shall provide information on the offering at Instytuty.DrIrenaEris.com, and offer the Beauty Gift Cards available from the Store via Internet.
- 5. The values shown on the website for the products/services offered include VAT and are expressed in Polish zlotys; they do not include the delivery costs (if any). The delivery costs are listed under "Delivery costs".
- 6. The value of the Beauty Gift Card shown on the website at the time the order is placed by the Buyer is considered binding and final.
- 7. Details on the total value of the order including shipping costs are displayed after the Buyer has selected the delivery option and the payment method in the last step of checkout.
- 8. The minimum value of a Beauty Gift Card is PLN 150. All transactions are confirmed with a sale note in Polish zlotys. The delivery costs (if any) are shown on the invoice.
- 9. The Seller may launch a promotional offer whereby the values of Beauty Gift Cards shall be reduced. Promotional offers at the Store cannot be combined with other offers, unless otherwise stated in the Rules and Regulations of the promotion.

V. PAYMENT

- 1. Payment for the Beauty Gift Cards purchased at the online store can be made using the PayU online payment option or by cash or card if the Beauty Gift Card is collected from the Seller's premises. The payment date shall be the day of crediting the Seller's account.
- 2. Purchase of a Beauty Gift Card shall be confirmed by a sale note and the courier service shall be confirmed (i) for private individuals by a cash register receipt and (ii) for private individuals conducting business activity by a VAT invoice, with the reservation that the VAT invoice shall be issued once the private individual conducting business activity has indicated their NIP number on the order form.
- 3. The sale note and the invoice/cash register receipt shall be sent/handed to the Buyer together with the purchased Beauty Gift Card.
- 4. The Seller shall deliver the goods ordered using a courier company.
- 5. The cost of delivery to destinations in Poland depends on the payment method and the delivery option selected, and ranges from PLN 0 to 24.99. Orders are delivered in Poland only.
- 6. Orders are processed within up to 7 business days after placing the order.
- 7. The Seller shall be liable for failure to process orders in a timely manner due to causes attributable to the Seller.
- 8. The Seller shall not be liable for failure to process orders in a timely manner due to a force majeure event. If the circumstances occur that prevent the order from being processed in a timely manner, the Seller shall promptly inform the Buyer and provide an estimated date on which the order will be processed. In such an event, the Buyer may cancel the order in writing or by telephone.
- 9. Beauty Gift Cards may be collected personally from the Seller's premises on business days from Monday to Friday from 9 a.m. to 5 p.m. at the following address: Dr Irena Eris S.A., ul. Puławska 107A, Warszawa, or may be sent to the Buyer by courier (for a fee of PLN 24.99) in Poland only.

- 10. An order is considered successfully processed upon completion of all processing stages, including initiation of order processing by the Store, handover of the consignment to the courier and its delivery to the Buyer.
- 11. The Store must deliver the Beauty Gift Card to the Buyer free from any defects.
- 12. After concluding the contract, the store shall deliver the Beauty Gift Card to the Buyer, jointly with a document on a durable medium serving as a confirmation of the contract made.

VI. DAMAGED CONSIGNMENTS

- 1. The Seller shall not be liable for any physical defect of the Beauty Gift Card occurring after the Beauty Gift Card has been handed over to a professional courier unless the Beauty Gift Card's physical defect results from a pre-existing cause affecting the product.
- 2. Before acknowledging receipt of the consignment, the Buyer must check whether the packaging has not been damaged during transport.

VII. PERSONAL DATA

- 1. DR IRENA ERIS Spółka Akcyjna, ul. Armii Krajowej 12, 05-500 Piaseczno, NIP (Tax Identification No.): 1230288525, REGON (Business Statistical No.): 012186410, KRS (National Court Register No.): 0000051003, email address: Instytuty.Biuro@DrIrenaeris.com, shall be the Controller of Buyer's personal data.
- a) Provision of the Buyer's data is voluntary and conditions conclusion of the Beauty Gift Card sale contract, whereas failure to provide these data shall prevent conclusion of the Beauty Gift Card sale contract.
- b) The Buyer's personal data shall be processed in connection with performance of the contract, for accounting and tax purposes, and identification and pursuit of claims, if any.
- c) The Buyer's personal data shall be handed over to a courier company for the purpose of shipment of a Beauty Gift Card ordered by the Buyer (sub-processing). The personal data entrusted by the Controller shall be processed by the Processor exclusively for the purpose specified herein.
- d) The Buyer's personal data shall be stored until the contract has been performed/dissolved/terminated or the Buyer has withdrawn its consent to personal data processing* and until the claims, if any, have become prescribed, counting from the date of performance/dissolution/termination of the contract or withdrawal of the Buyer's consent to personal data processing* unless the EU or national laws require personal data to be stored for a longer period.
- e) The Buyer has the right to request access to, rectification, erasure, restriction of processing of their personal data and to data portability.
- f) The Buyer shall have the right to object to the processing of its personal data within the scope referred to in letter b), to lodge a complaint with a supervisory authority and to withdraw its consent at any time without affecting lawfulness of data processing based on the consent before its withdrawal.
- g) The Controller shall not process personal data for marketing purposes.
- h) The Controller has appointed the Data Protection Officer who may be contacted in all matters involving data processing at the following email address: iod@drirenaeris.com.

VII. FINAL PROVISIONS

- 1. These Rules and Regulations are available at the Seller's premises, as well as online at: Instytuty.DrIrenaEris.com.
- 2. The Buyer may access these Rules and Regulations any time.
- 3. The Seller reserves the right to amend these Rules and Regulations for valid reasons, including in particular: 3.1) amendment of legal regulations on consumer law and e-commerce, 3.2) change of the payment methods,
- 3.3) change of the delivery options,
- 3.4) change of the legal form of business.
- 4. Amendments to the Rules and Regulations shall not apply to orders which have been already placed and processed. All accepted orders shall be governed by the Rules and Regulations effective at the time the order was placed.
- 5. These Rules and Regulations were published on 1 July 2022.
